Post-Pandemic Economic Recovery

The territory is a source of resources and innovation. The territory is, moreover, a place for meeting, conviviality and culture. In short, it is the space where social practices take place and the place where people and institutions live together.

From a territorial approach to development, people produce and consume goods and services within the framework of institutions that regulate social, economic and environmental practices. This relationship between actors and institutions makes the territory a space for dialogue and coexistence, as well as a place for conflict. Co-responsibility and availability for consensus are key in the pursuit of solutions to achieve free and cohesive societies.

Through this activity, UCLG's Committee on Local Economic and Social Development, within its adapted work plan for 2020 and aligned with the roadmap of the 5th World Forum on Local Economic Development, encourages the empowerment of its members in accordance with the priorities highlighted by the World Organization.

In accordance with the main thematic axes of the 5th World LED Forum, this training aims to strengthen knowledge generation, dialogue and the construction of local tools. As well as the exchange of good practices among peer learning on innovation for territorial cohesion, in the context of economic recovery after the crisis caused by COVID-19.

CONTENTS

They address a number of eminently practical issues. They tackle territorial innovation in local economic development as a basis for socio-economic recovery after the coronavirus crisis.

This training is aimed at sharing, analysing, debating and generating ideas that can be applied by local and regional actors in the generation of local economic development strategies for socio-economic reactivation, in a global context of great uncertainty and with major social, economic and environmental challenges.

Emphasis is placed on shared, networked work, which facilitates international spaces for consultation, the generation and production of knowledge and the exchange of experiences and good practices in socio-economic recovery after the COVID-19 crisis, taking into account visions from different territories.

It serves as a framework for the roadmap to the V World Forum on Local Economic Development.

KNOWLEDGE CONTENT. As a framework prior to the practical content, they address descriptive and graphic questions about the basic concepts of each unit addressed.

INNOVATIVE CASE STUDIES. Attention to innovative experiences in LED is crucial for boosting economic recovery. Study examples to understand how innovative approaches could provide the means to overcome the crisis.

PRACTICAL APPLICATION CONTENT. Focusing on the identified experiences, practical tools for innovation are compiled, offering guides and practical instruments from the local and regional level.
