CHALLENGES

- Low level of collection of municipal taxes.
- Low level of implementation of public investment projects.
- High rate of chronic child malnutrition.
- Limitations and excessive bureaucracy in administrative procedures, does not present favorable conditions for promoting local competitiveness.
- Deficient provision of public services.
- Lack of any disaster prevention policy
