The role of national Local Governments Associations

For the national associations, global agendas present an opportunity to internationalize their municipal agenda.

The Localization of the SDGs can improve the capacities of its municipalities and provide international visibility for the progress made at a local and regional level.

Raising Awareness

Helping LRGs and citizens understand their role in:

- 1) the implementation of the SDGs in their territories
- 2) the definition and evaluation of national and territorial strategies.

Advocacy

Facilitate the participation of LRGs in the development of national SDG strategies to ensure they reflect and respond to local circumstances, needs and priorities, following a bottom-up approach.

Reporting

It serves as a way to be more transparent and accountable, both inwards and outwards.

It can help strengthen coordination and cohesive policy and effective implementation of the SDGs.

Capacity Building



Co-organize a conference or event presenting the national consultation strategy.





Foster the localization of the SDGs and its mechanisms & a bottom-up approach.

The objective of UCLG is to raise awareness for the Sustainable Development Goals (SDGs) along local and regional governments, their associations, and networks to assist them in the localization process.





What is in the learning pipeline?

- 1. **Online courses** localizing the SDG, creating a Trainer community. 2nd course on localizing the SDG of 60 hours starts end of September
- 2. Massive online courses MOOC piloting a Mini Mooc on COVID response and on cultural strategies
- 3. MODULE 4 on localizing the SDG in Decentralized Cooperation
- 4. NEW area of Localizing the Sendai Framework and Resilience Development
- 5. Strategic use of webinars and engage trainer community promote the exchange of practices among members, identifying policy challenges
