# Project "Strengthening the network *Estratégia ODS*"

The project aims to strengthen *Estratégia ODS*, a multi-sector network of organizations whose main goal is to contribute to the implementation of the SDGs in Brazil. With local governments, the project supports the revision and elaboration of planning instruments oriented by the SDGs. As for now, 73 cities have achieved the expected results.



## **Challenges:**

- Dissemination and implementation of the SDGs in Brazil
- Increasing inequality
- Decline of participation forums



**Main objective:** contribute to the effective implementation of the SDGs in Brazil

**Local planning and the SDGs:** methodology for the revision and elaboration of multiannual plans

- Are there any local policies and/or regulations related to the SDGs?
- Creation of a working group or local commission
- Which public bodies contribute to the achievement of each SDG target?
- Which of the existing programs and actions contribute to the achievement of each SDG target?
- Which relevant targets the government is not tackling?

# 5. Lessons learnt

## **Challenges**

- No guidance for local governments nor national coordination
- Local technical teams are willing to work with the SDGs, but the involvement of the leaders (mayors and secretaries/heads of department) is usually low
- Low integration among municipal secretariats
- Lack of indicators adapted to the local level
