Project description:

- Raise awareness and train national associations of local governments and officials from cities on the implementation or "localisation" of the SDGs, territorial planning, as well as monitoring and evaluating global agendas
- Sharing and exchange of experiences and good practices, to increase the level of awareness and defense of local actors in the implementation or localisation of SDGs, territorial planning and monitoring, reports and evaluation strategies for global agendas;
- Propose measures and tools that facilitate the effective participation of local governments and their associations in the process of implementing and monitoring and evaluating plans and strategies aimed at reaching the SDGs;



1. Institutional setting



- ANAMM led the process as part of the plan (2019) to localise the SDGs in the municipalities for having started a new cycle of Municipal Governance (2019-2023). An opportunity to raise awareness among the newly elected.
- The Government of Mozambique adopted the 2030 Agenda and integrated it into its Five Year Plan (2015-2019). The Ministry of Economy and Finance coordinates the group created to monitor the implementation of the SDGs in Mozambique, a national reference group for the implementation of the SDGs, of which ANAMM is part.
- UCLG (learning department) provided material support for the training modules and part of the trainers.
- The remaining partners: PNDU (which also supports the Government of Mozambique) and GIZ provided financial support for the project.
- They were also involved the representatives of the academy and other partners working in the municipalities.

In terms of methodological approach, the session was guided as follows:

Practical exercises with group work and the elaboration of action plans.

Theoretical content: through presentations on the different aspects of the theme, experts will be included, including an understanding of the SDGs, implementation principles and conditions, steps, methods, tools to examine, monitor and evaluate the actions carried out in the target population;

Practical work: These theoretical contents were followed by discussions and complemented by group work and practical exercises, in order to allow participants a better control of the methods and tools for implementing examination, monitoring, reports and evaluation of local performance in the location of the SDGs;

5. Lessons learnt



The participants (municipalities) easily identified themselves with the SDGs even though they did not know the knowledge or history. However on a daily basis they carry out various service prescribing activities linked to the SDGs (water supply, improvement of environmental conditions through solid waste management).

The training should include a greater number of technicians in the municipalities to avoid that the rotation does not affect the implementation of the appropriate tools.
