1. Institutional setting

- Local elections in September 2011 brought change in political leadership
- The leadership identifies the continuation and reform of participatory budgeting in its "coalition agreement" as a political priority for the legislative period 2011-2016
- Federal Agency for Civic Education (bpb) as a companion
- The participatory budgeting committee is put together as a core committee in the development phase



2. Starting point

Various objectives/critic fields had to be addressed:

Timeframe: Streamline the period between proposal submission and implementation.

Role distribution between politics, citizenship and administration: mobilising, activating and involving citizens in the implementation process; reawakening political interest; project-specific dialogue with citizens and administration

Revise internet presence: focus on proposal submission, dialogue and proposal tracking; integration of social media services



3. Approach

- Create time to perform an evaluation and development process
- Develop an appropriate work structure: Working committee with sub-working groups (consideration of interest groups)
- Involvement of external cooperation partners and experts
- Keep results and procedures flexible and alive and understand them







4. Outputs

- Proposals can be submitted all year round
- Acceleration of proposal processing through structured processing procedures (e.g. intrayear procedure) and preliminary evaluation
- Consistent personalisation of all citizen suggestions
