

2.Recap: Your action plan/project ideas

- The plan noted the need for attention to the following aspects as part of the turnaround strategy:
- A need to engage in political lobbying to get support for the Solid Waste Management Plan.
- Organising a sustainable SWM fee model.
- Increasing overall resource recovery at a reasonable rate of 15% over the next three years.
- Through behaviour and attitude change to strive for 100% collection coverage in the city.
- Importantly it was recognised that change of this nature would require increased participation from stakeholders in resource recovery.
