Monitoring of measures in air pollution control planning



Monitoring, Enforcement Control & Impact Check

Monitoring observes the process of implementation and all those impacts that are made through the policy interventions

The purpose of a periodic monitoring is to check whether the measures implemented by different partners in their own responsibility are actually realized (enforcement control) and to what extent the statutory objectives have been achieved (impact control).

The authorities responsible for the implementation of the individual measures report to the District government up to the 1st March of each year on the current state of implementation of the previous year. The concrete implementations must be named and described.

The district government of Arnsberg then reports on the State of implementation of the measures to the Ministry of Environment, Nature, agriculture and transport by the 01st April each year.

As the framework conditions and influencing factors can change in the implementation process, the possibility of flexible adaptations must be kept open within the framework of action-oriented impact control. This may mean, for example, an adjustment of the action concept in the context of a continuation of the air clean-up plan or the elimination of certain measures.

The main focus of the monitoring is that the effects of the various measures on air quality are observed and analysed constantly. For this purpose, the national Office for Nature, Environment and consumer Protection will carry out the measurements further.



Praktische Umsetzung der Vollzugskontrolle

The notified measures implementation levels are compared with the measures in the respective air clean-up plan

The implementation status of the measures will be differentiated into 3 categories and be highlighted in the list for a better overview

The measure has been implemented or implemented —green-The measure is ongoing or is in the implementation —yellow-The measure has not yet begun —red-
